# What is D-SNAP?

D-SNAP stands for Disaster Supplemental Nutrition Assistance Program. This federal program provides emergency food stamps for individuals and families affected by major disasters.

# Can I Receive D-SNAP?

To receive D-SNAP, all of the following must be true:

1. Your income is **no greater** than the maximum amount allowed for a household of your size, as detailed below:

**Example 1**: If your household has 4 people and a combined income of \$3,900, then your household would be eligible for D-SNAP.

**Example 2**: If your household has 4 people and a combined income of \$4,500, then your household would **NOT** be eligible for D-SNAP.

- 2. You suffered damages to your apartment, house, or car; you have had to pay to eat out, to relocate, or loss of income from Hurricane Sandy.
- 3. You were living in the following zip codes on October 27, 2012:

#### Brooklyn

Coney Island: 11224 and 11235 South of Allen Avenue: Part of 11229 Red Hook: 11231

Staten IslandMaSoutheastern Shore: 10306LoSouth of Seaview Avenue: Part of 10305

#### Queens

The Rockaways: 11691, 11692, 11693, 11694, and 11697

#### Manhattan

Lower Manhattan: 10002

Unfortunately, households who have ONLY experienced food loss as a result of Hurricane Sandy will <u>NOT</u> be considered eligible.

# I already receive SNAP benefits. Am I still eligible for D-SNAP?

Not exactly. If you have SNAP, you should automatically get a D-SNAP payment on your EBT card to raise you to the highest amount allowed for the number of people in your home. You do not have to apply to get this increase.

However, if you already receive the highest amount of SNAP benefits possible, you will not receive any increase from D-SNAP.

#### I am an undocumented immigrant. Am I still eligible?

Yes. You can apply for D-SNAP even if you are not a citizen or permanent resident.

#### What information and documentation will I need to apply?

- → Some form of identification, such as a driver's license.
- ➔ Proof that you lived in one of the affected zip codes (listed above) on October 27, 2012, such as a lease or a utility bill.
- ➔ If possible, proof of what the storm has cost you. For example, proof that the storm has affected your income, your resources, and/or the people who live with you.

#### When and where should I apply?

**Note**: If you are unable to visit these sites yourself, you can send someone to represent you. That person should know all the necessary details about your situation in order to apply on your behalf.

# What happens if I am approved for D-SNAP benefits?

You should receive a temporary benefits card in the mail within 3 to 7 days. The following chart specifies the amount you will receive. For example, if your 3-person household is eligible for D-SNAP and earns \$3,000 per month, you will receive \$526.

#### My application was denied. Can I appeal?

Yes. If your household applied for D-SNAP benefits and was denied, you may request a fair hearing. If your household did not apply during the schedule period, you do not have the right to a fair hearing.
