## **JOB ANNOUNCEMENT**

### **TEMPORARY STAFF ATTORNEY MENTAL HEALTH LAW PROJECT**

Mobilization for Justice (formerly MFY Legal Services), a non-profit legal services organization that provides a wide range of free civil legal services to low-income New Yorkers, is seeking a temporary staff attorney to join its Mental Health Law Project for one year. The Mental Health Law Project assists people with mental health disabilities living in the community by providing advice, counsel and representation on housing, public benefits, disability rights, consumer, and other matters. The temporary staff attorney will focus on providing advice, advocacy, and representation for people with mental health disabilities who are having housing-related problems.

MFJ's mission is to achieve justice for all. MFJ prioritizes the needs of people who are low-income, disenfranchised, or have disabilities as they struggle to overcome the effects of social injustice and systemic racism. We provide the highest-quality free, direct civil legal assistance, conduct community education and build partnerships, engage in policy advocacy, and bring impact litigation. We assist more than 14,000 New Yorkers each year, benefiting over 24,000. MFJ has a staff of more than 165 attorneys, paralegals, social workers, and support staff. It is a diverse, unionized, and collegial workplace where staff share the organization's mission to achieve social justice.

#### **Responsibilities include, but are not limited to:**

- Conducting client intakes in person and on the telephone.
- Providing advice, advocacy, and representation for people with mental health disabilities who are having housing-related problems.
- Conducting community outreach, trainings, and education.
- Inputting and maintaining records in our case management system.
- Notarizing your clients' court or other documents as necessary.

#### **Requirements:**

1. Admission to the New York State Bar.
2. Demonstrated interest in working with people who have mental health disabilities.
3. Excellent research and writing skills.

#### **Preferred:**

1. Experience representing people in New York City housing court.
2. Fluency in Spanish, Mandarin, Cantonese, Russian, Haitian Creole, French, Bangla, Korean, Arabic, or Urdu.

**Salary** is pursuant to a collective bargaining agreement with excellent fringe benefits. The salary range for this position is \$73,742.62 to \$128,365.06.
