## Job Announcement – Paralegal/Legal Services Assistant Government Benefits Project

Mobilization for Justice (formerly MFY Legal Services), a non-profit legal services organization that provides a wide range of free civil legal services to low-income New Yorkers, is seeking a paralegal/legal services assistant to work with Mobilization for Justice's Government Benefits Project. The candidate will provide a wide-range of legal services for low-income New Yorkers, including SSI/SSD benefits for adults and children, health benefits, including Medicaid and other insurance, Supplemental Nutrition Assistance Program (SNAP), and other benefits. The candidate will also assist immigrants who are seeking citizenship, adjustment of status, replacement of lost or expired green cards, and other benefits.

## Responsibilities include, but are not limited to:

- Conducting client interviews in person, on the telephone, and at community-based organizations, sometimes in the evenings;
- Providing advice, counsel and brief services under the supervision of an attorney;
- Assisting individuals in completing relevant applications and forms;
- Advocating for clients with the Human Resources Administration, Social Security Administration, the Board of Immigration Appeals, U.S. Citizenship and Immigration Services, and other government offices;
- Representing clients at administrative hearings;
- Representing immigrants before the Immigration Courts;
- Conducting community outreach and education;
- Creating and updating community educational and training materials; and
- Inputting and maintaining records in case management system.

## **Requirements:**

- College degree;
- One year of experience working on benefits or immigration issues;
- Strong organizational skills and ability to manage various responsibilities;
- Excellent writing and communication skills;
- Excellent database and computer skills;
- Willingness to see clients, conduct clinics, and trainings throughout the five boroughs of New York City, sometimes in the evening;
- Ability to work collaboratively yet independently;
- Willingness and ability to become an accredited representative at the Board of Immigration Appeals; and
- Fluency in Spanish, French, Arabic, or a Chinese Dialect.

Paralegal experience a plus.
