Job Announcement Staff Attorney – Civil Legal Services for People with Mental Illness

Mobilization for Justice (formerly MFY Legal Services), a non-profit legal services organization that provides a wide range of free civil legal services to low-income New Yorkers, is seeking a staff attorney to represent people with mental illness in civil legal matters. The staff attorney will work in MFJ's Mental Health Law Project where the primary emphasis is on eviction prevention, ensuring income stability (including obtaining and maintaining government benefits and addressing barriers to employment), and access to healthcare. Affirmative outreach, advocacy, and litigation are encouraged to address problems affecting people with mental illness. The Mental Health Law Project works in collaboration with mental health providers and social workers in inpatient and outpatient settings using a medical-legal partnership model.

Responsibilities include, but are not limited to:

- Conducting client intakes in person, on the telephone, or at off-site clinics, including clubhouses, outpatient clinics and hospitals.
- Conducting factual investigations, including site visits.
- Providing clients with advice, brief service and direct representation.
- Researching, writing, and litigating all phases of cases including pleadings, motions, discovery, briefs, hearings, trials and appeals.
- Appearing for clients in Housing Court, Supreme Court, Civil Court, Federal Court and administrative agencies, including NYCHA, HPD, DHCR, HRA, OTDA and Social Security.
- Conducting community outreach and trainings.
- Training mental health providers on substantive law and the rights of people with disabilities.
- Identifying, developing, and commencing impact litigation or policy initiatives to address problems affecting people with mental illness.
- Administrative and legislative advocacy and lobbying on issues of importance to people with mental illness.
- Working in coalition with advocacy groups on policy issues.
- Providing testimony on proposed legislation or other legislative body topics.
- Communicating with elected officials and the media.
- Inputting and maintaining records in our case management system.
- Fluency in Spanish sufficient to conduct an intake interview is strongly preferred.

Requirements:

1. Admission to NYS Bar.

4.2. Well-organized and capable of managing a diverse caseload.

- 2.3. Experience or demonstrated interest in working with people with mental illness, people with disabilities, veterans, seniors, people with substance use disorder, or people who are homeless.
- 3.4. Ability to balance individual casework with impact litigation or advocacy initiatives.
- 4.5. Two years of experience in housing court or working on government benefits issues preferred.

Salary is pursuant to a collective bargaining agreement.
